Pursuant to the provisions of Article 22.5.1, nomination(s) to the General Committee shall be in writing and signed by a proposer and a seconder, both of whom should be members of the HKAA, and endorsed by the candidate by way of confirmation of his consent to act if elected.

In accordance with the provision of the same Article, a candidate shall, at the time of his nomination have been a member in good standing for a period of not less than one year from the date of his admission to membership.
