Criteria for National and International Competition Licence

地區及國際比賽執照準則

Any person who wishes to participate in any motorsport competition, National or International, must be in possession of a valid competition licence of the appropriate Category, Type and Grade as specified in the Sporting and Supplementary Regulations of the corresponding competition. Please refer to the updated FIA International Sporting Code and related appendixes for details.

任何香港居民如欲參加任何賽車運動，必須持有有效及合適的賽車執照。而該執照的種類、類型、等級則須符合該項比賽及附加規則內訂明的要求。國際執照的要求及規定必須遵照國際汽車聯合會最新公報之賽車運動準則及相關附例為準。
